**No of Students to be admitted – 50 (35-SC and 15 –OBC).**

### **1. Eligibility criteria**

A. Qualification (minimum graduation from recognized university)

B. Selection would be through written test & Interview at Samkalp Bhawan, Plot No 15, Sector IV, R. K Puram, Institutional Area, New Delhi 110022.

(i) Written test will be held on **1<sup>st</sup> May 2019, Wednesday between 10.00am to 11.00am**. Test would be objective type. 60 questions-(Questions would be from last one year’s Current affairs in public domain).

(ii) **Candidates should report at Samkalp Bhawan by 9am sharp.**

(iii) On the basis of marks obtained in written test about 200 candidates will get **their original documents verified**, immediately after the written results are announced. **Candidates will appear in interview next day on 2<sup>nd</sup> May 2019 from 10.00am onwards.**

**Arrangement for expenses on to and fro travel, boarding and lodging at New Delhi, have to be made & borne by the candidates only. Tea and Lunch will be provided at Samkalp Bhawan on 1<sup>st</sup> and 2<sup>nd</sup> May 2019.**

C. Selected candidates have to report at Samkalp Bhawan R.K Puram New Delhi latest by 9am on 9<sup>th</sup> May 2019, to complete admission formalities. Classes will start from 10<sup>th</sup> May 2019.

**2. Students belonging to SC/OBC, having total family income from all sources of Rupees 6 lakhs or less per annum will be eligible for benefits under this scheme. For this purpose income declaration of self employed parents/guardian should be in the form of a certificate issued by Revenue Officer not below the rank of Tehsildar. **Employed parents/guardians should obtain income certificate from their employer. Thereafter employed parents/guardians should also obtain consolidated certificate from Revenue Officer for any other additional source of income, or give a self declaration if they have no other income other than from employment. 4. Please bring all relevant documents in **Original with two set self-attested photocopies, on 1<sup>st</sup> May 2019 for the written test.**
